Your Excellency,

Allow me to convey, on behalf of IFOAM – Organics International, our warmest congratulations for your decision to transition Sri Lanka from chemical farming to natural farming.

We, as the global agent of change for organic farming, welcome this wise decision as a clear indication of Sri Lanka's intention to make its food systems fully sustainable and inclusive in order to meet the Sustainable Development Goals and the commitment of the Paris Agreement on climate change. Inclusivity means taking care of all stakeholders of these food systems, and first and foremost farmers, who produce the food Sri Lankan people eat every day and whose livelihoods are fully dependent on these food systems.

We have been advising governments on such transformational policies for decades and gathered much experience through this. Please allow us to share some of our thoughts on what steps are necessary, in our opinion, to bring your great initiative to a success.

While such a transition is very timely for any country, the period during which the whole sector can adapt to knowledge intensive techniques used e.g., in organic farming might take 2-3 years, based on our experience. We are closely following the progress made in Bhutan, the Indian state of Sikkim, the Nepali province of Karnali and Juancavelica in Peru, which are all following the route of converting to 100% organic. The pace of their development clearly tells us the need for a careful planning in order for none of the farming families to be left behind. After all, your decision implies nothing less than a major transition with a comprehensive, holistic approach!

We operate a <u>platform for policy makers</u> around the world to find a safe space to share and have an exchange on transformative policies. Your government officials are highly welcome to join <u>here</u>.

This transition time will allow not only for farmers to build up critical microbial life of their soils, but also to put all the other necessary measures in place to establish the academic basis for natural farming and vocational training at all levels. This includes universities, extension services being capacitated to advise on sustainable management techniques, and funding for

research on locally adapted solutions specific to the main crops produced in the country, as well as subsidies available for farmers to convert to organic agriculture.

Such a stepwise approach would also allow sufficient time for the gradual reduction in the use of synthetic fertilizers and making available and subsidizing the purchase of knowledge, skills and inputs necessary to start chemical free, organic agriculture.

Once again, let us express our admiration towards your courageous decision. Together with experts in Sri Lanka and particularly the Lanka Organic Agriculture Movement, we remain at your disposal to provide you with our experience and further thoughts. We would also be delighted to have experts in your Government join a series of workshops we organize, wherein the Road Map will be discussed and world-known experts will express their support and further suggestions for the transition Sri Lanka is going through. We will send you the details on these in the coming days.

The scale of an Organic District is dependent on the conditions in each country. It could be at community level, region or for a province.

- In Europe there are 50 Organic Districts
- The first Organic District was established 17 years ago in Cilento, southern Italy

It also calls for a reduction by 50% of the use of chemical pesticides by 2030. An "Action Plan for Organic Agriculture" was adopted in April 2021. This plan has three Axis: Demand and consumer trust; Conversion and value chain and Organic leading by example and 23 concrete actions.

In Action 14 of the plan the European Commission Encourage Member States to support the development and implementation of "Bio-districts" (Organic Districts)

Your Excellency,

On behalf of three hundred member organizations from 16 countries and territories in Asia, IFOAM Asia, deeply welcomes the recent and very opportune decision of your esteemed government to adopt more regenerative organic farming practices "to transform Sri Lanka into a Green Socio-Economy with Sustainable Solutions for Climate Changes".

As of December 2020, more than 110 countries in the world have come up with national strategies of achieving carbon neutrality by the year 2050 and transformations into more sustainable and organic agriculture are now taken into consideration as one of the pathways to achieving this goal and to deliver on the UN Sustainable Development Goals.

As an example, the "European Green Deal" was published in December 2019 as a roadmap to achieving zero carbon. It includes the "European Organic Action Plan" which aspires that 25% of agricultural land in Europe to be organic by the year 2030. It also calls for a reduction by 50% of both the use of chemical pesticides and the use of more hazardous pesticides by 2030.

There are any similar action plans in Asia where national governments are taking measures to achieve zero carbon. In Asia, the Japanese and South Korean governments have unveiled their strategies of decarbonization achievable within twenty years. The State of Sikkim became the first state in the world to become 100% organic and Bhutan is on its way to becoming fully organic.

IFOAM Asia as the leading regional organic organization in the continent has assisted many central and local governments in formulating organic policies and implementing action plans in the field. The recent launch of the Participatory Guarantee Systems (PGS) of the Philippines as part of its national organic regulations is such an example of working in long-term partnership with a central government; and through the Asian Local governments for Organic Agriculture (ALGOA), IFOAM Asia has worked closely with local governments to implement central government policies and to link up with the organic farmers and other stakeholders in the organic sector through capacity-building, technology assistance and building up of local markets.

In addition, IFOAM Asia has positioned the role of our smallholder farmers as vital in the transformation to regenerative organic agriculture as our smallholder farmers are the backbone of our society - as providers of the food we consume, as caretakers of our health and as the stewards of Mother Earth.

Our smallholder farmers are often the poorest of the poor, disadvantaged with little or no access to their own land. They also have limited access to public services such as education, health and other social benefits and uneven access to market opportunities. This becomes more severe within indigenous populations and other marginalized groups.

Globally, 90% of farms worldwide are less than two hectares and more than 2 billion people depend on them for their livelihoods. There are some 500 million smallholder farms worldwide and these small farms produce about 80 per cent of the food consumed in Asia and sub-Saharan Africa.

This means that smallholder farmers can be part of the solution to global food security, helping to feed the world by improving productivity and crop diversity. But they cannot do it alone.

Your Excellency,

Nothing is important in this era of the COVID-19 than health and immunity of the people. The world has been united to protect the lives and health of humanity and the concept of "One Health" and "One Planet" has gained prominence. This can be seen in the increased sales of organic food in many countries, and it is local and organic food that has been the key in maintaining health, immunity, and nutritional balance of the people, and the sustainability of our world.

And that has been only possible due to our smallholder farmers. It is now time to recognize fully the role of the smallholder farmers

IFOAM Asia urges your esteemed government to recognize the multi-functional roles of our smallholder farmers and to implement policies and support measures to facilitate the transformations into regenerative organic agriculture.

As an experienced and leading organic organization in Asia, IFOAM Asia is aware of the challenges involved in the transitioning from chemical to a more sustainable and organic agriculture in a country level.

Support Letter from the President of ALGOA and Mayor of Goesan County, Lee Cha Young

Support Letter to the Government of Sri Lanka into Transition from Conventional Farming to Organic and Sustainable Farming

His Excellency Hon. Gotabaya Rajapaksa President of Sri Lanka Presidential Secretariat Galle Face, Colombo 1, Sri Lanka

June 7th, 2021

Your Excellency,

On behalf of the 250 local governments who are members of the Asian Local Governments for Organic Agriculture (ALGOA) in 18 countries in Asia and Central Asia, I would like to convey my most sincere congratulations on your decision to transition from chemical farming to sustainable and organic agriculture.

ALGOA (www.organicgovts.com) was launched in 2015 and is an alliance of local governments in partnership with the private sector and civil society groups, with the purpose of making the transitions into organic agriculture. Almost all ALGOA members have adopted legislation banning pesticides and implementing aggressive organic policies and action plans. Many have seen great successes in their organic policy implementations and due to the resilience of the organic farming systems and well-established local markets, have fared better than most in the COVID-19 pandemic.

Your Excellency,

I would like to share some amazing success stories when central and local governments make the decisions to adopt organic farming.

First is the incredible success story of Dumingag Municipality in Mindanao Island, Philippines which decided to adopt organic agriculture as its centrepiece and managed to bring down the rate of poverty from 96% to less than 30% in the space of 4 years and eliminated hunger.

Second, in the case of the Municipality of Kauswagan, Philippines, the "Arms to Farms" organic farming program turned rebels into exemplary organic farmers and brought much needed peace and prosperity to the war-torn and hunger-stricken municipality.

Third, in East Asia, pro-organic mayors worked with local organic farmers to provide organic vegetables and rice to school lunch programs. An initiative that was first started by New Taipei City, expanded to all schools in Taiwan to provide organic vegetables in school lunches and greatly increased organic vegetable production in the country. In Japan and South Korea, mayors linked up with organic rice farmers for the provision of organic rice to school lunches.

Fourth, an interesting program that was initiated by the South Korean government was the pilot "Pregnant and New Mothers' Organic Food Scheme" as part of the COVID-19 recovery package. The project started from 1st January 2020 and targeted 80,000 pregnant women and new mothers. The idea was to provide access to organic food from inception to birth and through all the school years.

The examples in the above are just but few of the success stories I have encountered when central and local governments undertake aggressive proorganic policy implementations and specific action plans.

Your Excellency,

The decision of your esteemed government to transition into more sustainable and organic agriculture would have wide impacts on the lives of your people, the economy, on the environment and in the global organic sector.

The decision has galvanized the global organic movements into action to support in every way your country's goal "to transform Sri Lanka into a Green Socio-Economy with Sustainable Solutions for Climate Changes". This will also make Sri Lanka one step closer in achieving its goals of carbon neutrality and delivering on the Sustainable Development Goals.

As I close, in all humility, I would like to extend an invitation to Your Excellency to grace the 7th ALGOA Summit to be held from Oct 12th to 16th, 2021, under the theme "Regenerating More Resilient, Sustainable Local Food Systems".
